Office Order

This is to notify that the Vice-Chancellor of Bangladesh Open University (BOU) is hereby extending study leave to **Mr. Md. Nazim Mahmud**, Assistant Professor (Education), School of Education, Bangladesh Open University for a further period of 01 (one) year to undertake PhD Program at the University of Manitoba, Canada as per decision of the 75th meeting of Standing Committee for Advanced Studies, Training and Research of BOU held on 06 August 2019 and as approved in 167th meeting of Board of Governors of BOU held on 02 October 2019 and as approved by the Ministry of Education, Govt. of the People's Republic of Bangladesh on the following terms and conditions:

1. That the leave will be effective from 01 September 2019.
2. That on return, after completion of the said study, he will work in Bangladesh Open University for the same period of leave availed of, failing for which he will have to pay BOU compensations as may be assessed by the university.
3. That the progress and standard of higher study should be satisfactory and he should send progress reports on expiry of every 6 (six) months.
4. That his service during his study leave will be governed by BOU rules.
5. That as soon as he completes the said course, he will join Bangladesh Open University.
6. BOU will not bear any expenses for his PhD Program in the University of Manitoba, Canada;
